## 6. FRSM President Report - Andrea Johnson

Andrea presented a verbal FRSM President Report to accompany her message in the annual report. Key points included:

- Stating that the RSM has renewed their agreement with FRSM and the negotiation process went smoothly.
- Highlighting the success of the Solstice Series in partnership with SGI, which is a partnership that will continue.
- Highlighting the success of Artifact Artificion and the second annual Friendraiser.
- Thanking the staff, board, and members of the FRSM & RSM for all their hard work.

## 7. RSM Executive Director Report - Brie Hnetka

Brie presented a verbal RSM Executive Director Report. Key points included:

- Celebrating the successful year of the RSM, stating that they had the best attendance since the pandemic.
- Approximately 132,000 people visited the RSM, while the T Rex Discovery Centre had around over 9,000.
- Stating that there was an increase in donation per visitor.
- Celebrating the success of MegaMunch's retirement which largely contributed to the increase in visitation.
- Celebrating the success of Artifact Artificion, the Solstice Speaker Series, and the Traditional Knowledge Keeper Series.



- Highlighting new additions to the RSM including “Take a Closer Look,” a life size mural in the T Rex Discovery Centre, and an interactive topographic layer table in the Discovery Lab.
- Celebrating the new high school programs, drop in family programming, and workshops, stating that they focus on creating new and continuing old programs to attract new visitors and keep previous visitors engaged.
- Celebrating the success of events held during Indigenous storytelling month.
- Stating that RSM researchers published nine (9) papers, won two (2) awards, and have been featured in media eighteen (18) times.
- Stating that they worked to digitize the Indigenous Ethnology Collection to make it more accessible to different communities.
- Celebrating the creation of the Birds Eggs of Canada website.
- Thanking board members, both present and outgoing, for their hard work.
